## SNOW ORDINANCE IN EFFECT

### ORDINANCE TITLE III

#### 3-3-30 PARKING DURING SNOW EMERGENCY

No person shall park, abandon, or leave unattended any vehicle on any public street, alley, or City-owned off-street parking area during any snow emergency proclaimed by the Mayor unless the snow has been removed or plowed from said street, alley or parking area and the snow has ceased to fall. A snow emergency parking ban shall continue from its proclamation through the duration of the snow or ice storm and the forty-eight-hour period after cessation of the storm except as above provided upon streets which have been fully opened.

#### Mayor Proclamation for the 2025 Winter Season:

Snow/Ice in excess of 2" is forecasted, is occurring, or has occurred, any/all vehicles must not be parked in streets, alleys, or any city owned parking area until streets have been cleared and/or for 48 hours after cessation of the snow event, whichever is later.

The City is not responsible for blocked driveways due to clearing snow from streets. It is the resident's responsibility to clear their own driveways/sidewalks without returning any snow to City Streets and Alleys.

Backwash water – no update  
 Nuisances – Car was towed last month, letters have not been sent yet from last meeting, those vehicles still in place, will send out this month to add overflowing dumpster at the apartments. Discussed what to do about a resident who has broken water pipes and non-working meter, access to the basement is unsafe with a wall to the entrance caved in. Will instruct Water Superintendent to shut the water off as an emergency to protect the water system and notify the home owner that water will not be turned on until safe entrance can be made to install a water meter at the customers expense.  
 Water System Updates – none, can remove from the agenda for now.  
 Park relocation – Several inquiries from interested parties to buy the old park. Will put it out for sealed bids with an allowance to come to the bid opening and raise their bid, with the City holding the right to reject any and all bids. Motion by Arends to hold the bid opening at the March meeting, 2nd by Noelting. Approved.  
 Septic – Dan Tilkes suggested to a council member that there may be enough room for the Library and Post Office to share a septic tank.  
 Building permits – none.
