ORDINANCE SPOTLIGHT

Lets make our town look more welcoming this Spring! As you are probably aware, junk, junk cars, and nuisances have been a priority for the City Council over the past couple of years. While the town has much improved over that time, there is still work to do. Here are a couple of Ordinances that address these issues, the full text can be found on our website, or you can review the official code book in the Alexander City Hall.

Title III Community Protection

Chapter 2 Nuisances

“The term “nuisance” means whatever is injurious to health, indecent, or unreasonably offensive to the senses or an obstacle to the free use of property, so as essentially to unreasonably interfere with the comfortable enjoyment of life or property”

This chapter covers numerous items including trees, weeds/grass, junk/garbage, noise/smells, etc.

Title III Community Protection

Chapter 8 Junk and Abandoned Vehicles

“The purpose of this chapter is to protect the health, safety, and welfare of the citizens and safety of property of this City by providing for removal of abandoned motor vehicles and the elimination of the open storage of abandoned and junk motor vehicles and machinery except in authorized places”

PICK UP YOUR DOG WASTE! IT'S THE LAW!

Title IV Chapter 1 Section 4-1-4 of the Alexander Code of Ordinances: ANIMAL NUISANCES. It shall be unlawful for any person to permit an animal under such person's control or within such person's custody to commit a nuisance. An animal shall be considered a nuisance if it (1) Damages, soils, defiles, or defecates on private property other than the owner's or on public walks and recreation areas unless such waste is immediately removed and properly disposed of by the owner.

The Consequence? 4-1-5.... "Any dog found at large in violation of Sections 4-1-3 and 4-1-4 of this chapter shall be seized and impounded, or, at the discretion of the Mayor, the owner may be served a summons to appear before a proper court to answer charges made thereunder"
